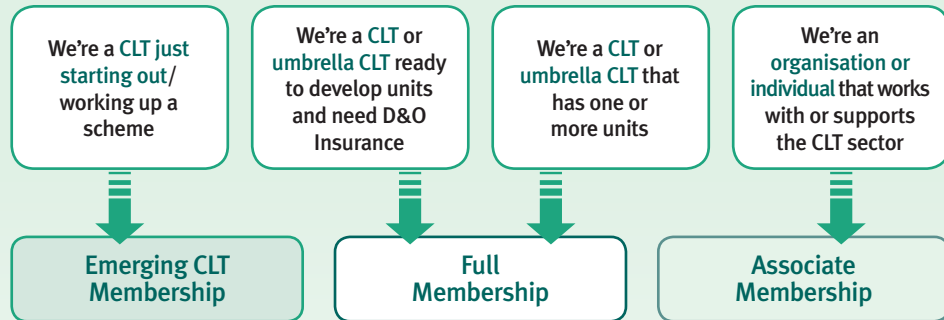


Which membership is right for me?

Full membership of the National CLT Network

Why should I become a Full Member?

Specifically tailored to meet the needs of a CLT or Umbrella CLT who is developing or has developed homes or other community facilities, full membership includes:

Emerging CLT Membership

Why should I become an Emerging CLT Member?

Specifically tailored to meet the needs of emerging CLTs who are not in a position to become full members but would benefit from:

Am I eligible?

Only if you define yourself as a CLT but are at early stages of development and don't have any units, or are an individual setting up a CLT in a voluntary capacity.
